- Need 38 more approvals, would like 44 if possible
- 952 total, 250ish outstanding
- 675 approvals, 4 disapproves
- Feedback: members not knowing what this was for - they are not getting it

## Open Board Position / Rachel Bouma

Maggie resigned, effective in June, which leaves one spot open. We have at least one person nominated.

- It's short term as the remainder of Maggie's term which takes us to December 2023. If they are interested in another term they can run again.
- Previously had discussed going back to those that ran and didn't get elected
- Justin nominated: Jason Ott (via email to Rachel)
- Luke nominated: Bill Malaier, a lawyer
- James nominated: Andrea McNealy, a lawyer

## Locker Room Project Update / James Wonneberg

We are getting all "ducks in a row" this month, to get it all ready to roll. Prices have been fluctuating (lumber up and down, labor rates are higher) so the final cost will be a mixed bag.

- Start day: September 5th
- Setup of the temp bath shower/facially slightly before then
- Once we sign, we can get a better look at cash flow, etc.
- Fence line in front of pro shop etc to separate pool

Speaking of the pool - we asked for umbrellas on the side with blue lounge chairs. Tom is working on it.

## Manager's Report / Tom Peterson

Successful PNW Tournament (129 years): a ton of people came out

We'll need a committee for next year (130 years!)
Positive feedback for member and pro tournaments: it was cool to have them together

We charged all members for Member Tournament (\$25 per singles and \$50 per doubles team.) We charged members playing in the PNW the $\$ 80$ entry fee.

No charge to enter this year - members should get in free, having it not advertised was positively received

Charges should go to prize money
Housing was not done this year (2019, 34 homes were open) things are different this year, feedback from some members that they'd want it back

Action: Call for committee members in September. Possible items to discuss/decide:

- Bio for each player (a program) AND a bracket!
- Limit people to one category so you're not competing against yourself
- Auto-charge for members (Historically it was $\$ 20$ - make it $\$ 50$ ?)
- Housing details
- Ball boys and girls
- Scores upkeep during matches
- Excessive heat on the courts and stands - how to solve for that
- Appreciation gifts for those who did the work
